5. **Reports/Discussion**
 - a. **Principal Update** (Heather Jenkins)- Ipads and Headphones for students recently added. 3rd graders doing test prep after school. Next week doing holiday activities with students. Performing for Cristo Rey students and parents on December 22nd. Teachers and Team doing well. Working on becoming self sponsors for free and reduced lunch program. Currently on final step, which involves a site visit. Program should be up and running by 2nd semester. We have been approved as a title one school. Currently we are a level 2 because we are 84% free and reduced lunch. Still waiting on parent forms so our percentage will be even higher. We currently will get \$600 per students and as a title one we will get \$750 per student. will come out to \$30,000 this year we can use for the school.b.
 - b. **Lottery Dates** - Need to come up with lottery date so we can develop our marketing plan.
 - i. Suzanne indicates they have one lottery date at Dayspring and drive all their marketing toward that date. Parent info session in February and March is open enrollment. Then board members pull names or they use a lottery program. They send out letters of acceptance by email, but CP's population probably requires physical mail as well. Current students must sign a letter of inter to stay in February/March.
 - ii. Heather wants to have an event during School Choice week (week of Jan 21st). It would be a welcome back/open house event. We would also announce title 1 status. Need to develop marketing materials in advance of this event. Heather recommends february as enrollment month, first

business day of march as lottery day. January 20th would be parent info session.

- iii. We have 82 open slots. 54 or more will be kindergarten. Should have open houses in February as well. If we miss the mark on enrollment, we should have another enrollment period in April.
- iv. Crystal makes a motion to approve March 1st as our first lottery date. Suzanne seconds. No objections. Vote passed by unanimous consent
